#### PROCEEDINGS OF THE GOVT, OF KARNATAKA

ORDER NO. FD 07 CSL 2023 BENGALURU, DATED 18-07-2023

# The Government hereby accords approval to the Scheme called Karsamadhana Scheme, 2023. Features of the scheme are as follows:

- 1. It grants waiver of 100% of arrears of penalty and interest payable by a dealer under the Karnataka Sales Tax Act, 1957 (hereinafter referred to as the KST Act) and Central Sales Tax Act, 1956 (hereinafter referred to as the CST Act) relating to the assessments / re-assessments / rectification / revision / appeal order already completed and as the case may be, to be completed on or before 31-10-2023 under the KST regime.
- 2. It grants waiver of 100% of arrears of penalty excluding those specifically mentioned and interest payable by a dealer under the Karnataka Value Added Tax, 2003 (hereinafter referred to as the KVAT Act) and CST Act relating to the assessments / re-assessments / rectification / revision / appeal orders already completed and to be completed on or before 31-10-2023.
  - 3. It grants waiver of
  - a. penalty levied under Section 72 relating to returns and assessments under the KVAT Act and consequential interest subject to the condition that the amount of tax as admitted in the return or assessed is paid in full.
  - b. penalty levied under Section 74 (4) for failure to submit copy of the audited statement of accounts in FORM VAT 240 under the KVAT Act & consequential interest subject to the condition that admitted tax liability, if any, as per FORM VAT 240 is paid in full.
- 4. It grants waiver of 100% of arrears of penalty and interest payable by a dealer or person or proprietor as the case may be relating to the assessments / re-assessments/rectification / revision / appeal orders already concluded & to be concluded upto 31.10.2023 under following Acts also, namely:
  - a. Karnataka Tax on Entry of Goods Act, 1979, (hereinafter referred to as KTEG Act);
  - Karnataka Tax on Professions, Trades, Callings and Employments Act, 1976 (hereinafter referred to as KTPTC and E Act);
  - c. Karnataka Tax on Luxuries Act, 1979 (hereinafter referred to as KTL Act);

- d. Karnataka Agriculture Income Tax Act, 1957 (hereinafter referred to as KAIT Act); and
- e. Karnataka Entertainments Tax Act, 1958, (hereinafter referred to as KET Act).
- 5. It grants 100% waiver of arrears of interest and penalty excluding those specifically mentioned, payable by a dealer or person or proprietor as the case may be relating to
  - a. revision order already concluded; or
  - b. revision proceedings initiated prior to the date of issuance of this Government Order and revision orders to be completed on or before 31-10-2023

in respect of all the Acts mentioned in the preamble.

#### **Applicability:**

- 1. All legacy Acts under Commercial Taxes, (KST, CST, VAT, KAIT, KET ,KLT, KTEG Acts including Profession Tax Act), excluding Betting Tax.
  - 2. 100% Waiver of Penalty and Interest levied.
- 3. Assessments/Reassessment/Rectification orders on or before 31.10.2023, duly signed.
- 4. If any appeal pending before First Appeal, KAT, HC and SC to be withdrawn before that and Rectification should have happened before 31.10.2023.
- 5. The last date to pay the due demand of tax before 31.12.2023.
- 6. Payment Extension Up to 15.01.2024, if applied on or before 31.12.2023
- 7. All Applications should be filed online mode only, on the following URL. http://gst.kar.nic.in https://vat.kar.nic.in/epay

#### **Non Applicability:**

- 1. If the assessment/reassessment/Rectification orders after 31.10.2023
- 2. If the Online Application applied after 31.12.2023(System does not accept at all)
- 3. If the Department has preferred appeal before KAT, HC, SC and dept. has taken uo SMR, such dealers are not eligible.

# Revamping of CGTMSE Scheme

for MSME from 01-04-2023

CGTMSE issues guidelines regarding reduction of annual guarantee fee for loans upto Rs. 1 crore from a peak rate of 2% per annum to as low as 0.37% per annum

# Limit on ceiling for guarantees enhanced from Rs. 2 crore to Rs. 5 crore

In Union Budget 2023-24, Union Finance Minister Mrs. Nirmala Sitharaman announced the revamping of Credit Guarantee Scheme for Micro and Small Enterprises with effect from 01-04-2023, with an infusion of Rs. 9,000 crore to the corpus to enable additional collateral-free guaranteed credit of Rs. 2 lakh crore & the reduction in the cost of the credit by about 1%.

Consequent upon this, the following significant steps have been taken:

- The corpus of Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE) has been infused with a sum of Rs. 8,000 crore on 30-03-2023.
- CGTMSE has issued guidelines regarding reduction of annual guarantee fee for loans upto Rs. 1 crore from a peak rate of 2% per annum to as low as 0.37% per annum. This will reduce the overall cost of credit to the Micro and Small Enterprises to a great extent.
- The limit on ceiling for guarantees has been enhanced from Rs. 2 crore to Rs, 5 crore.
- For settlement of claims in respect of guarantees for loan outstanding upto Rs,. 10 lakhs initiation of legal proceedings will no longer be required.

CGTMSE created a new landmark by touching the milestone figure of approving guarantees worth Rs. 2 lakh crore during 2022-23.

# Kalaburagi Mega Textile Park to be set up in 1050 acres at a Estimated cost of Rs. 1834 Crore

With this, Kalaburagi is likely to emerge as a major investment location considering its strategic location and infrastructure including connectivity, said Sri K. N. Narasimha Murthy, President KASSIA and observed that "as per official estimates, over 1 lakh people will get direct employment from this Mega Textile Park".

The State Government laid the foundation stone recently for Karnataka's Mega Textile Park at Kalaburagi District that will be set up under the PM Mega Integrated Textile Regions and Apparel (PM MITRA) Scheme.

The Mega Textile Park will come up on 1550 acres of land, and the total cost of infrastructure development of the Park will be Rs. 1,834 crore.

The Park will have plug-and-play manufacturing facilities and all the common amenities, including effluent treatment plants, accommodation for workers, skill training centres and warehouses. The Park is envisioned to attract investment from companies looking to scale up, requiring integrated manufacturing facilities in one location.

#### Kalaburagi Mega Textile Park

The State Govt. has already earmarked 1550 acres of land in Ferozabad, Nadisinnur and Honnakiranagi villages in Kalaburagi District.

Over 1000 acres of the land have already been transferred to the Karnataka Industrial Area Development Board, which is the agency to develop the infrastructure facilities for the Textile Park.

The Textile industry is the third primary industry in the country in terms of employment generation after the energy and coal industries.

#### **Founding and Execution**

On March 17, 2023 the Union Government announced seven Mega Textile Parks under the Rs. 4,445 crore PM MITRA Scheme.

Under the first phase of the PM MITRA Scheme, Large Textile Parks spread across at least 1000 acres.

The Mega Textile Park will come up in seven States-Karnataka, Tamil Nadu, Telangana, MP, Maharashtra, Gujarat and UP - housing the entire Textile value chain, from fibre to fabric to garments.

The Ministry of Textiles will oversee the execution of the Mega Textile Park projects.

A SPV owned by the Centre and State Government will be set up for setting up and operationalising each Park.

The Ministry of Textiles will provide financial support through development capital support up to Rs. 500 crores to the Park SPV.

A Competitive incentive Support (CIS) of up to Rs. 300 crore per Park to the units in PM MITRA Park shall also be provided to incentivise speedy implementation.

State Government will be responsible for providing contiguous and encumbrance-free land parcels of at least 1000 acres of land. They will also facilitate the provision of all utilities, a reliable power supply and water availability and waste disposal system, and an effective single window clearance system.

Jaju we put a word to Vadodra Chamber that we want to have an interaction meeting with Gujarat Industries Association and Chamber of Commerce Vadodra. They agreed and gave time in the month of July 2023 and the date was fixed as 7th July and itinerary was prepared by discussing with Dr. Bharat Boghara, who was from the same State living in Rajkot having 3 Textile spinning mills, 2, 250 MW solar plants and 200 MW wind mills. He was very happy about our visit to Textile Mills as well as to discuss with the Minister of Industries, Govt. of Gujarat, seeking any type of support.

We a group of 25 members (including special invitees) decided to make industrial study visit and started on 6th July





by Rajkot Express to Vadodra and reached Vadodra by 1 P.M on the following day on 07-07-2023. After having lunch at about 3 P.M. GIDC Savali Industrial Association President Sri J. K. Sharma and Secretary Bharat Patel were waiting for us to take us for a industry visit to Alstom atSavali industrial area, which is into manufacturing semi high speed Railway coaches. With the good relations of J. K. Sharma President, Savali Industries Association, they explained all the details of railway coaches, which are being exported to more than 9 countries in the world. After that we went to the office of Savali Industrial Association which is in the GIDC Savali of Vadodra. It has got 1.5 acre land with office building constructed with 2 big auditorium and a conference hall.

We were stunned to note that Gujarat Govt. has given them that land with building at a nominal cost of Rs. 1 per sq. ft. i.e. the support of Gujarat Govt. to Industries Association. One more thing that surprised us is that they get reimbursement of whatever they spend on the industrial programmes they do. This is really a boost to industries association, so that they can take up lot of programmes to encourage growth and development of industries.

In the evening we had Meeting with Vadodra Chamber of Commerce and Industry, Vadodra and other 10 industrial associations. The hospitality shown by them was unforgettable. We had good interaction with all the industries Associations and President of Vadodra Chamber of commerce and Industry Vadodra. Many of the questions asked by our members like what is the procedure of allotment of site, industry registration, skill training and loan facility they told us that just making an application signifying your intention that you want to start an industry is sufficient. After that the Govt. will start following you up to establish an industry within 3 months without any hurdles and the Govt. and Industrial Association will see that this industry grows and develops. From 7 P.M. to 9 P.M. we had long discussions with experts of different industry associations who are running their industries since 30 years about how industries growth and stability is maintained.

Next day on 8th July we were to visit a Tourist Place namely Statue of Unity (Sardar Vallabhai Patel statue). But on 7th evening we received a letter from Chief Minister's office stating that we are (team of 25 members from KKCCI) are guests of Gujarat Govt..one Mr. Parikh who is Secretary in the CM's Office sent us a letter and 2 Tourist Guides at the Statue of Unity namely Mrs. Chitra Naragunda and Miss. Shweta were asked to take care of us on 8th Morning from 10.00 A.M. to 8.00 P.M.. We were really honoured by that letter. We left Vadodra at 8 PM and reached Kewada Statue of Unity. Guides were waiting for us. They boarded our bus and took us to Bird Sanctuary, Wild Life Forests, Medicinal Plants Nursery, Narmada River Dam, Thermal Power Plant and lastly Sardar Vallabhai Patel Statue which is biggest statue in the world with a height of 182 mtrs. Lunch and dinner were also hosted by Govt. of Gujarat. Guides Mrs. Chitra Naragunda and Shweta were so kind enough to explain everything in detail nicely and were very knowledgeable having experience of 20 years. After watching Laser Show our programme ended in Kewadia. They took us to a hotel run by tribal women and we had sumptuous food and returned back to Vadodra.

Next day we were guests of Dr. Bharat Boghara. We left Vadodraat 7 A.M. and reached Jasdan.We visited his 350 beddedhospital which is totally free hospital with multi speciality facility.Dr. Bharat Boghara was waiting for us and greeted every one with shawl and a memento. We went around the hospital which was really an eye openerfor all of us. Then we went to his Textile mill in Jasdan. We had lunch with Dr. Bharat Boghara hosted by him at his Textile Mill. It was raining that day but nothing could disturb our programme. We visited the spinning Mill which was 33000 spindles spinning unit. General Manager of M. M. Group of Industries took us around the whole milland explained about everything. It was a totally machine-managed industry with very less of manual labours. The turnover of M. M. Groups of Textile Industries is around Rs. 1500 crores.

We spent the eveningin the Mill and thenaround 6 PM we started for Dr. Bharat Boghara's farm house to relax and stay. We were accommodated very nicely in the farm house. In the night we had dinner with Dr. Bharat Boghara and his family and friends. Next day we started from Rajkot to Gandhi Nagar in the morning and reached around 2 PM. In the evening we had an appointment with Social Welfare Minister Smt. Bhanuben Manoharbhai Babariya Madam. Then we met Education Minister Sri Prafula Chhaganbhai Pansheriya and stayed in the house of Dr. Bharat Boghara. We had dinner hosted by Dr. Bharat Boghara. Next day morning our appointment was with State BJP President Sri C. R. Patil. He was so humble to greet us and treat us. Then

Dr. Bharat Boghara took appointment with Chief Minister of Gujarat Sri Bhupendra Bhai Patel on 11th Morning. We went to Vidhan Soudha to call on the Hon'ble Chief Minister of Gujarat. The Chief Minister spent 15 minutes with our team. Our President Sri Shashikanth B. Our meeting with Ministers and Secretaries of different Departments in Gandhi Nagar Vidhana Soudha gave us confidence that we too can pressurise our Govt. to encourage new Industries and help sick industries for their sustenance.

On the same day afternoon we left Ahmedabad by Air and reached Hyderabad in the evening and back to Kalaburagi same night.
