

SECRETARY REPORT

Dear Friends,

We are on the verge of completing term of 2 years which started in April 2023, with the excellent team of 32 members, we had their guidance, their co-operation, their effort and their enthusiasm to conduct many programmes and functions which made this term most successful. Starting with industrial visit, delegation to Delhi to meet different ministers to highlight problems of Kalyana Karnataka region was remarkable. We did many meetings with different Affiliated Associations, trying to solve their problems. GESCOM electricity Tariff was increased we went on agitation and called Kalaburagi Bandh by submitting memorandum to DC and MD of GESCOM. Even we went to an extent of filing a writ petition against KERC on the increase of electricity Tariff this was jointly done by all affiliated chambers of Kalyana Karnataka Districts in the Supreme Court. Property Tax was again a curse to Traders, Industrialists and Residents of Kalaburagi we called many meetings with Corporation Commissioner to show our dissatisfaction of increase in Property Tax. Trade Licence was another issue and took it seriously and arranged a help desk with City Corporation to help and make it easy for our Traders to get Trade Licence without any harassment by the department. Many traders took advantage of the same.

Dear Brothers, First of its kind in KKCCI, we were able to conduct "KRISHI JATRE" with 178 stalls for exhibition for 3 days and inauguration of Krishi Jatre was done at the hands of by Poojya Kadasiddeshwar Swamiji Kanneri math which was very grand success and attended by more than 10,000 farmers. 3 days exhibition was visited by lakhs of people, exhibitors also sold good quantity of their products and were also happy. With the untired effort of all Managing Committee members and Office Bearers, with the help of donors from Kalaburagi we were able to bring out "Krishi Jatre Souvenir" of 100 pages without any financial burden to chamber.

We had Inter - District meets in Raichur Kalaburagi involving all Kalyana Karnataka Districts to discuss problems of Traders mainly property tax and GESCOM Tariff increase. We also conducted 2 MC Meetings and Interaction with Taluka Trader one in Sedam and one in Shahabad to discuss the problems and solutions of Traders and Industrialist. We had meeting with Corporation and Police Commissioner to solve the problems of Traffic and Hawkers.

We have invited Small Scale Industries Minister Sri Sharanabasappa Darshnapur, Skill Development and Medical Education Minister Sri Sharanprakash Patil, Sri Ajay Singh, MLA Jewargi and Chairman KKRDB to our chamber to discuss the problems of our Traders and Industrialists and we had very good interaction. When there was a problem of Wholesales Traders and Retailers of different businesses in APMC Market we also joined hands with them and had meeting with APMC Minister Sri Shivanand Patil and with the help of Food Grains Merchants Association President Sri Santosh Langer, we were able to resolve it to some extent.

During this period the Chamber has conducted innumerable programs for the benefit of Traders and Industrialists and it is difficult to mention all, above are some of the programs. Last but not the least, with the effort of Office Bearers and MC Members, we could make an additions of two Property to chamber which is significant. All the documents like E-Khata and mutation are done which is also paged in this souvenir.

I would like to thank all our Past President senior most members of KKCCI and you all individual members who have given timely suggestions to foster the growth of KKCCI making my Secretaryship most successful during 2023-25. Thanks, Thanks, Thanks till Infinity.
